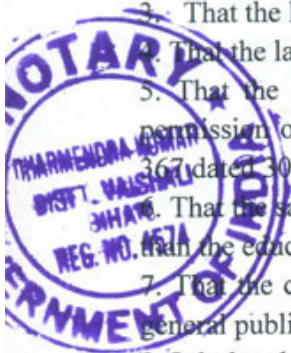




3. That the land is on **ownership basis**.


